- ❖ Covid-19 Bylaw is in affect for all Levels 1-5 and will be until the Epidemic is declared over by Public Health. The COVID-19 By-law replace the Provincial regulations for COVID-19
  - ❖ Unified Command is active at all levels
  - ❖ Social Distancing 2 Meters and Mask Wearing is Mandatory in public buildings and public places at all Levels 1,2,3,4 & 5
  - ❖ Level 1 & 2 No Emergency
  - ❖ Increase Police Presence at all Levels 1,2,3,4 & 5
- \* Level 3, 4 & 5 Community State of Emergency

Private indoor or outdoor gathering max 15 persons or three families from a max of three dwelling units

Activities organized in public setting max 50 people indoor max 150 people outdoor

Public Halls (Galgoasiet) max 50 people

Depanneurs / Casinos open \*personal dwelling gaming max 10 people

Inter-regional travel, in and out of community no restriction

Private indoor or outdoor gathering max 12 persons or three families from a max of three dwelling units

Activities organized in public max 50 people indoors outdoors 100

Place of worship / cultural max 100 people

Public Halls (Galgoiset) max 50 people

Depanneurs / Casinos 50% capacity \* personal dwelling gaming max 5 people

Inter-regional travel, in and out community no restriction

Private indoor or outdoor gathering max 10 persons or 3 families from a max two dwelling units

Activities organized in public setting indoor and outdoor max 25 people

Public Halls (Galgoasiet) max 25 people

Casinos 50% capacity \*personal dwelling gaming max 5 people

Depanneurs 3 clients at a time

Inter-regional travel not recommended

Private indoor and outdoor gathering prohibited

At Home 8 persons up to 3 dwellings units

Activities organized in a public setting indoor and outdoor prohibited

Place of worship/ cultural prohibited

Public halls (Galgoasiet)Prohibited

Casino's closed\*including gaming in a personal dwelling unit

Depanneurs 3 Clients at a time

Personal and beauty care services (if in personal dwelling closed)

Community organizations maintained (Coop,, Daycare, Chalet)

Inter-regional travel not recommended

Curfew implemented 12 :00 a.m. 6:00 a.m.\* If required

Community State of lockdown up to 30 days renewable for an additional 30 days max 60 days

At home: no visitor \*only persons authorized by unified command

Mandatory closure of Community organizations (Coop, Daycare, chalet)

All Public Band Buildings closed \*Only Essential services offered

All businesses to be shut down with the exception of the Depanneurs & Gas station 1 client at a time

Inter-regional travel prohibited \*exception essential travel
